#### **Water Committee**

### Water Usage

All water meter readings were recorded on November 1st. October water usage was as follows:

- 686,250 gal, ~2.1 acre-ft. (September 2020 2,123,250 gal, October 2019 505,600 gal)
- 22,137 gallons per day.
- ~249 gallons per day per household.
- The average household used 7,623 gallons, with 10 households using greater than 15,300 gallons (~2X the average) during the month.
- System leakage was 0.2% for the month.

#### Maintenance

- Completed monthly maintenance.
- Completed 4<sup>th</sup> quarter maintenance
- Completed annual and semi-annual maintenance for October.

## Other

The pump house fence, damaged by a tree during a windstorm, has been replaced.

## **Secretary's Report**

Prep work for the annual meeting mailing has been ongoing. The billing policies and the 2021 budget, after being approved at this board meeting, will then go the printer and the annual meeting packet will be mailed to the neighborhood by Monday, November 16.

### **Landscape Maintenance Committee**

The Fall Clean Up Day on October 3 was successful, with 15 neighbors coming out to help spruce up the common areas.

A tree service was hired to remove dead and dying trees in the vicinity of the pump house and mailbox kiosk. Several trees with dead lower limbs were also pruned.

During a windstorm in October, a large tree blew down on the pump house fence and did quite a bit of damage. Several people with chain saws came and helped clean up and haul the tree away. In the event some of the regular volunteers are unavailable, it would be useful to have a volunteer list for common area and road cleanups due to storms.
