Cougar Ridge Homeowners Association Board of Directors' Meeting Summary July 8, 2020

President Olson called the meeting to order at 4:00 pm.

Treasurer's Report

Judy reported that she has completed the Secretary of State filing for non-profit corporations for the year.

Water Committee

Water Usage - June

All water meter readings were recorded on July 1st. June water usage was as follows:

- 1,938,200 gal, ~5.9 acre-ft. (May 2020 1,453,000 gal, June 2019 2,917,600 gal) 64,600 gallons per day.
- ~726 gallons per day per household.
- The average household used 21,056 gallons, with 11 households using greater than 42,000 gallons (~2X the average) during the month.
- We used nearly 1,000,000 gallons less this month compared to June 2019.
- System leakage was 1.3% for the month. (A bit high due to post maintenance flushing).

Maintenance

Completed monthly maintenance.

Other

Replaced eight distribution/blow off valves completing the valve work for Capitol Forest Drive. Next year we will go after the valves on Capitol Forest Loop and the private drive.

Complaint Response and Compliance

It was discussed that some garbage and recycle cans are left out on the street for longer than garbage days.

There were instances of 4th of July fireworks debris left in the streets.

President's Report

The board continued the discussion on the vote-by-mail procedure.

Lloyd made a motion to approve the July 6th revision of the procedure, Judy seconded the motion, and the motion was approved unanimously.

Discussion continued on the wording for CC&R Section 6.1 – Compliance with Zoning, specifically Section c. "Does not itself use Association resources, including, but not limited to, water from the Cougar Ridge Water System, *beyond de minimis usage.*" Barry made a motion to approve the new wording, Susan seconded the motion, and the motion was approved unanimously.

Discussion continued on the wording for CC&R Section 6.1 – Compliance with Zoning, specifically Section d. "Is not rented or leased for a period less than one month, or for any other vacation rental arrangement." The board would like to send this to the HOA attorney for more info.

The board approved an adjustment to CCR Section 6.16 - Open Fires, adding "dried" to Section *d* and eliminating Section *e* as follows:

d. Individuals are only permitted to burn paper, dried wood, charcoal, artificial logs, or clean fuels such as natural gas or propane.

e. Individuals should not burn green or wood that is not dried in order to limit nuisance smoke.

The Annual Meeting ballot format was reworded for use with the CC&R mail-in voting. Barb will make some modifications and send back to board for approval. Susan will draft a procedure for how to challenge the election results.

Susan and Lloyd will make a field trip to look at street lighting to address a few dark stretches of the neighborhood streets.

The August meeting is at Lloyd Moody's on Wednesday, the 12th.

The meeting was adjourned at 5:44.
