# Treasurer's Report

Judy reported that there are five outstanding water accounts as of today.

# Finance Committee

Pete reported the highlights of the draft 2022 budget approved by the Finance Committee:

- The HOA dues were raised 5% to \$248
- The Water System assessment was raised 5% to \$53
- Capitol items include: another round of valve replacements, a new roof and siding for the pump house, and a fence to shield the compost pile. James Ashley-Coles drew up the plans for the roof and siding. These projects are to upgrade the HOA common areas.

Pete made a motion to approve 2022 budget as submitted, Debbie seconded the motion, and the motion passed unanimously.

## Water Committee

#### Water Usage

All water meter readings were recorded on November 1st. October water usage was as follows:

- 590,300 gal, ~1.8 acre-ft. (September 2021 1,924,100 gal, October 2020 686,250 gal).
- 19,041 gallons per day.
- ~214 gallons per day per household.
- The average household used 6,413 gallons, with 8 households using greater than 13,000 gallons (~2X the average) during the month.
- System leakage was 2.1% for the month.
- The 12-month rolling total for water usage is 47.2 acre-feet. We are permitted for 63 acre-feet.

#### **Maintenance**

Completed monthly maintenance.

Completed 4<sup>th</sup> quarter maintenance

Completed annual and semi-annual maintenance for October.

#### <u>Other</u>

- Added two blowoff valves which were never installed when the water system was constructed.
- Irrigation was added to the landscape islands on Ridge High Court and Rocky Mtn Drive cul-de-sac.

## Secretary's Report

Barb has been getting the annual meeting packet ready for taking to the printer and getting out in the mail.

# Landscape Maintenance Committee

The common area landscape beds have been weeded and preened for the winter. A few more native plants were added to The Pit and it was weeded and preened as well.
