



Logging Plans For Area Behind Cougar Ridge

Beautiful Hillsides Behind Cougar Ridge Are "Working Forests"


Our Cougar Ridge Neighborhood, which borders on the DNR (Department of Natural Resources) property called the McLane Creek Nature Trail, is located in Capitol Forest. Those beautiful hillsides behind our Cougar Ridge neighborhood are called a "working forest." It means that parcels of the forest are frequently scheduled for auction and logging. Two parcels called Bears U1 and Bears U2 are scheduled to be auctioned in 2026 and logging will begin in 2027. These parcels are right behind the McLane Creek Nature Trail.

People Raise Concerns About Logging Logging has been an important resource from our area, and a source of many jobs. However, many people are raising concerns about the logging of our forests. According to the Seattle Times, Washington's forest trust lands raise about \$180 million a year for schools and local government services, including hospitals, libraries, EMS, and more. Another \$63 million is used to manage and maintain over two million acres of land and 14,000 miles of roads. According to the *Seattle Times*, Thurston County Commissioners have asked for a pause on sales in the Capitol State Forest, to protect big trees for biodiversity, human well-being, and to preserve the carbon stored in these large trees. Capitol Forest's undeveloped working lands provide habitat for native plants and animals, water retention and water quality benefits, as well as diverse recreational opportunities. Actively working to stop the logging of Bears U1 and U2 parcels, are the **Friends of McLane** group, that is also citing concerns such as impact on the annual salmon runs, increased fire danger, harm to wildlife, possible landslides, and declining property values. **Basic Information Informs Neighbors About Complexities**

Backup Generator Ensures Continuity of Fresh Water



Winter Weather Brings Threat of Power Outages

Our approaching winter always brings the threat of rain, snow, wind and...power outages. Our water system has a backup generator to help ensure the continuity of a fresh water supply to the neighborhood. However, homeowners need to be aware that if their septic system relies on a pump to move grey water to the drain field, extended power outages could be a problem without a home backup generator.

If You Have A Septic Pump Longer Outages Could Cause Backup

Short duration power outages (hours) are typically not a problem and should not limit your water consumption. Longer outages (days), without backup power for your septic pump, could result in your system exceeding its capacity causing drains to backup into your home. That can be messy.

Duration of Power Outages Encourages Limiting Water Usage

The duration of a power outage is seldom known so it is best to limit your water use without a home backup power source.

Please Check Your Nearest Storm Drain Regularly for Clogs


Our Neighborhood is home to drains, ditches, stormwater ponds, runoff receptacles, and common area landscape beds with curbs. During storm events these features can become plugged from melting snow, leaves and debris. Lot owners are requested to help prevent flooding by clearing these clogged areas frequently. Here are some suggestions from **Thurston County's Stream Team**: Look after your neighborhood storm drain by keeping it clear of leaves, snow, and other debris.

✔ Use a rake and dustpan or a shovel to remove leaves and debris.

✓ Put leaves and debris from storm drains in your garbage bin, since they are contaminated with roadway pollutants.

Snowplowing Regulations Favor Neighborhood Mobility

Heavy Snowfall Makes Navigating Our Streets Difficult

In the Pacific Northwest, we are fortunate to get very little snowfall, but some winters we have gotten inches to a foot or more of snow. Oh yes, it certainly does make it difficult to navigate our streets when there's been a heavy snowfall. (editor's note: I remember taking a yardstick outside and measuring 22 inches several years ago! That year we called the snowfall a "snowpocalypse"!) In order to prepare for the occasional snowstorm we may receive, please familiarize yourselves with the Board's snowplowing policy details on the Cougar Ridge website. Just to refresh your memories, here is a brief description of what's allowed and what isn't. The roads in Cougar Ridge are public roads. Thurston County oversees the upkeep, maintenance, and liability of all their roads. Thurston County Public Works

explains that, "Crews maintain a fleet of plows, anti-icing trucks and graders in preparation for significant weather events including snow, ice and windstorms. Priority is given to major arterial roadways and secondary connections."

Please Become Familiar With Board's Snowplowing Policy The website for Thurston County Public Works states, "After priority and secondary roads are cleared, crews address residential routes. Crews do not plow subdivisions and driveways." This policy burdens many neighborhoods like ours, whose roads do not meet this standard. Therefore, the policy allows the Cougar Ridge Board to develop an acceptable approach for the Board to hire a snow-plowing service to clear the roads.

Cougar Ridge's Board Will Be Proactive In Hiring Snowplowing Services If Needed

The need to utilize snowplowing will be determined by the Cougar Ridge Board. The Board will proactively engage with the community before, during and after snowfall events as appropriate. The determining factors will be 1.) the estimated amount of snow on the roads, 2.) the estimated length of the storm, and 3.) the forecasted temperatures.
