President Lindstrom called the meeting to order at 7:04 pm.

President's Report

Judy made a motion to elect Barry Olson as President, Lloyd seconded the motion, and the motion passed unanimously.

Lloyd made a motion to elect Pete Valinske as Vice President, Judy seconded the motion, and the motion passed unanimously.

Barry made a motion to elect Barb Valinske as secretary, Judy seconded the motion, and the motion passed unanimously.

Barry made a motion to elect Judy Lundgren Treasurer, Pete seconded the motion, and the motion passed unanimously.

Water Committee

Water Usage

All water meter readings were recorded on December 1st. November water usage was as follows:

- 380,800 gal, ~1.2 acre-ft. (October 2019 505,600 gal, November 2018 390,500 gal)
- 12,700 gallons per day.
- ~143 gallons per day per household.

The average household used 4,222 gallons, with 5 households using greater than 8,400 gallons (~2X the average) during the month.

System leakage was 1.3%

Our 12-month rolling total for water usage is 46.0 acre-feet. Our annual calendar year permit limit is 63 acre-feet. Since 2016 we have seen a reduction in water consumption of nearly 9% per year:

Year	Usage
2016	60.3 acre-ft, or 19.65 million gallons
2017	55.0 acre-ft, or 17.92 million gallons
2018	51.1 acre-ft. or 16.65 million gallons
2019	46.0 acre-ft, or 14.99 million gallons (estimated)

Maintenance

- Replaced the water meter at Lot 71 due to its failure.
- Performed annual distribution valve cycling. Two valves remain for exercising.
- 4th quarter maintenance is in progress.

The January meeting is at Barry Olson's on Wednesday, the 8th.
