### **Architecture Review Committee**

- Lot 77 would like to remove three trees
- Judy Lundgren and Barb Valinske will put together a landscape guide, with required elements, to help the ARC with new landscapes

## **President's Report**

The old zig-zag fence on the pipeline at Rocky Mountain Drive was removed for mowing for the 4<sup>th</sup> of July picnic. The timbers are falling apart and a new fence will be installed this summer. The board is also looking into a nicer gate replacement. Williams Pipeline will be on hand to supervise the digging of postholes.

The board would like to have Williams Pipeline replace and update old safety signage, <u>as</u> requested last year.

The board will determine if motorized vehicle guidance signage should be placed at the top and bottom of the pipeline. Purpose to inform visitors, and others unfamiliar with Pipeline Policy - something like: "**Motorized Vehicles Restricted -** Authorized Deliveries Only"

### **Water Committee**

# Water Usage

All water meter readings were recorded on July 1st. June water usage was as follows:

- 2,917,600 gal. ~9.0 acre-ft (May 2019 1,945,450 gal.; June 2018 1,186,200 gal.)
- 94,116 gal. per day (Apr. ~64,850 gal. per day)
- ~1,057 gal. per day per household.
- The average household used 32,534 gal., with 6 households using greater than 65,000 gal. (~2X the average) during the month of June.
- System leakage was 0.1%.

#### Maintenance

- June monthly maintenance was completed. DWP flow remains at about 177 gpm.
  Checking weekly.
- Second quarter maintenance was completed.
- Booster Pump #2 motor bearings are causing some vibration in the pump and motor.
  Greasing the bearing helped to dampen the vibrations.

## **Landscape Committee**

Three dead trees were removed near the pump house.

A small group of neighbors has volunteered to help with maintenance of the landscape beds and other jobs that come up to help with the workload and improve volunteer participation. The board will check with landscape services for an estimated cost. ACTION: Barb

There are some undeveloped lots that have noxious weeds growing. In accordance with Thurston Co. rules on weeds, the owners will be notified to control the weeds. ACTION: Barb

The August meeting is at the Valinske's on Wednesday, the 14th.

The meeting was adjourned at 9:28.
